### Gavin Boyles, Esq.

I am a graduate of Haverford College and Vermont Law School. I began my legal career clerking for Chief Justice Reiber, for whom I had interned during law school. After clerking, I transitioned to private practice in Burlington, focused primarily on land use and insurance. In 2011, I returned to Montpelier and spent the next five years in the Environmental Protection Division of the Attorney General's Office. In October 2016, I accepted a position as Assistant General Counsel with the Department of Financial Regulation. Since February 2018 I have been the Department's General Counsel, supervising eight attorneys and one paralegal.

I was on the board of the VBA Young Lawyers Division from 2009 through 2017 and served as Chair of the Division in 2015-2016. I also served on the VBA Board of Managers from 2014 through 2017. This year I have served as VBF Board President, and I have been a member of the VBF Board since 2017. As a member of the Board, I've seen that the VBF's mission and work align closely with my values and that serving on the VBF Board is deeply satisfying.

I live in Montpelier with my wife and our two children, ages 12 and 16 (and four guinea pigs and a steady stream of toddlers at my wife's home daycare).

I am honored to be considered for re-election to my position on the VBF Board. As a member of the VBF Board for the last four years I've seen that the VBF's mission and work align closely with my values. I have found serving on the VBF Board, including this past year as Board President, deeply satisfying.
