ABOUT US

The Vermont Bar Foundation (VBF) is Vermont's only foundation solely dedicated to strengthening the legal services community and expanding access to justice. Our mission is clear and deeply rooted in equity: to ensure that low-income, underserved, and marginalized Vermonters can access the legal support they need to remain housed, safe, and secure in their rights. When a person cannot afford legal help, the consequences touch every part of life - stability, safety, and the ability to fully participate in one's community.

Since our founding, the VBF has been built on both innovation and impact. Through Vermont's Interest on Lawyers' Trust Accounts (IOLTA) program, we transform the pooled interest from short-term client funds into public-good legal aid - turning an otherwise unused resource into a vital lifeline for thousands of Vermonters each year.

Each year, the VBF awards grants to nonprofit organizations in every region of Vermont, ensuring that legal support reaches rural towns, urban centers, and communities in between. These grants fund essential services - from housing stability and disability rights to family advocacy, domestic violence support, and restorative justice - meeting Vermonters where they are and responding directly to pressing community needs.

A cornerstone of our work is the Poverty Law Fellowship, a flagship program that places new attorneys directly into underserved legal areas. These Fellows stand at the front lines of our justice system, representing vulnerable clients, addressing systemic barriers, and expanding legal access across the state. The Fellowship reflects our belief that investing not only in programs, but in people, strengthens Vermont's justice ecosystem from the ground up.

At its heart, the Vermont Bar Foundation is more than a funder. We serve as a bridge between the legal community and every Vermonter, ensuring that access to a lawyer, to advocacy, and to justice is not a privilege reserved for a few, but a reality available to all.

MISSION | To create a just community by funding legal services for the disadvantaged and developing programs that enhance the understanding of and access to the Vermont legal system.

JUSTICE IN MOTION

Access to justice is a movement — this year, the Vermont Bar Foundation moved forward together with our partners and community. We invested not only in programs, but in people — creating opportunities for collaboration, visibility, and shared learning across Vermont's justice landscape. These gatherings strengthened relationships, elevated voices, and built momentum for a more connected statewide justice ecosystem.

JUSTICE SOCIALS

We were proud to host the first-ever series of Justice Socials, a new statewide networking initiative designed to bring together attorneys, advocates, nonprofit partners, and community leaders. One of these events was held in partnership with the Burlington Business Association, expanding our relationship with Vermont's business community and fostering deeper cross-sector collaboration. Together, these events helped spark new conversations and build a stronger, more connected justice network.



JUSTICE ROUNDTABLE

In partnership with Congresswoman Becca Balint's office, we convened a Justice Roundtable at Vermont Law and Graduate School's Burlington campus. Leaders from legal aid organizations, survivor services, disability rights programs, youth-serving organizations, immigration defense groups, and statewide coalitions came together to examine emerging challenges, share data, and explore collaborative solutions to expand legal access in Vermont. The Roundtable highlighted the power of collective problem-solving and renewed our commitment to statewide justice coordination.


FIRST ANNUAL JUSTICE GALA

A milestone moment for VBF and our partners. The first annual Justice Gala, hosted in partnership with Vermont Legal Aid and Legal Services Vermont, brought Vermonters together to celebrate access to justice and recognize the advocates, attorneys, and organizations strengthening our justice ecosystem every day. The event was generously supported by sponsors across Vermont's legal and business communities, demonstrating broad and unified investment in expanding civil legal aid. The Gala raised critical funding for legal services and established a new annual tradition centered on community, gratitude, and impact.



BY THE NUMBERS

The Vermont Bar Foundation is truly a statewide organization, supporting more than 4,000 Vermonters this year through civil legal services spanning immigration support, domestic violence advocacy, housing stability, family law, disability rights, and rural legal clinics. GRANTMAKING IMPACT

IOLTA AND THE HON. JOHN A. DOOLEY COMPETITIVE GRANTS PROGRAM

The Vermont Bar Foundation administers two core grant programs funded through the Vermont IOLTA (Interest on Lawyers' Trust Accounts) Program: the invite-only IOLTA Grants Program and the Hon. John A. Dooley Competitive Grants Program. Both programs are supported by interest earned on pooled client trust accounts and are designed to expand access to civil legal services and justice-related education across Vermont. The IOLTA Grants Program provides targeted, strategic funding to key legal service partners through an invitation-only process, ensuring stable support for essential, high-impact legal services. The Hon. John A. Dooley Competitive Grants Program is the Foundation's open, competitive funding program, awarding annual grants to nonprofit organizations that deliver direct legal services to low-income Vermonters and provide law-related public education. Together, these programs represent the Foundation's primary investment in Vermont's civil justice infrastructure, supporting innovation, accountability, and statewide access to justice.

THE RICHARD CASSIDY SPECIAL GRANT PROGRAM

The Richard Cassidy Special Grant Program is a \$100,000 statewide funding initiative created by the Vermont Bar Foundation to honor the life and legacy of attorney Richard Cassidy, whose career was defined by justice, public service, and removing barriers for Vermonters. Through this program, the VBF awarded special grants to 21 organizations working across Vermont to address critical needs including housing stability, disability rights, youth services, economic opportunity, immigration support, LGBTQ+ advocacy, and community reentry. The program reflects Richard Cassidy's enduring values and the Foundation's belief that access to justice extends beyond the courtroom—strengthening communities, expanding opportunity, and supporting Vermonters in meaningful and transformative ways.

POVERTY LAW FELLOWSHIP

The Vermont Poverty Law Fellowship empowers outstanding young attorneys dedicated to expanding access to justice for low-income and marginalized Vermonters. Funded entirely through robust fundraising efforts and generous contributions from law firms, individuals, businesses, and community partners, the Fellowship provides two years of critical salary and program support to emerging legal advocates working on the front lines of civil legal need. Since its launch in 2008, the Fellowship has strengthened Vermont's legal services ecosystem by building capacity in high-need areas, supporting innovative legal projects, and cultivating the next generation of access to justice leaders across the state.

I credit my Vermont Poverty Law Fellow (VPLF) experience with preparing me to lead Vermont Asylum Assistance Project (VAAP), even in uncertain times. While law school equipped me with core lawyering tools like legal research, writing, and analysis, the VPLF equipped me with the local context and relationships and leadership skills that I draw from daily to leverage VAAP's growing legal services program and affect positive systems-level change.
